*Should you place an order with Wildlife Reflections Taxidermy Studio Inc, either by delivering trophies to our premises or by paying a deposit for the provision of services you are deemed to accept these terms and conditions and agree to be bound by them.*

*All tanning is accepted at owner's risk. Wildlife Reflections Taxidermy Studio Inc, has no control over any skin or trophy prior to receiving it for tanning and/or mounting. Many factors have a definite effect on the final results of tanning, such as primeness, time of year, weather conditions, hot or cold, and care given to skin or trophy in the field when it was killed. Therefore, Wildlife Reflections Taxidermy Studio Inc, cannot assume any guarantee or liability for tanning.*

*A deposit of 50% is required on all contracted taxidermy work. Other payment options maybe available for some applications.*

*Any trophy delivered to Wildlife Reflections Taxidermy Studio without the required deposit will have a 30 day grace period. After 30 days the client will be contacted by mail and will have 5 business days to make the required deposit, plus a \$25.00 late fee. The late fee will increase \$25.00 for every 5 business days until deposit and late fees are paid. After 60 days without the required deposit and late fees, the owner of said trophy or trophies will relinquish all rights to the said trophy or trophies; Gifting their trophy or trophies to Wildlife Reflections Taxidermy Studio, INC.*

*Due to material and overhead costs, any deposits or payments made to Wildlife Reflections Taxidermy Studio, INC. Are not refundable under any circumstance.*

*Average work time is 18 months from paid deposit date. No work will begin until the required 50% deposit is made.*

*International trophies require owner contact information prior to arrival at Wildlife Reflections Taxidermy Studio Inc. All international shipments arriving at Wildlife Reflections Taxidermy Studio will be under a consenting work clause from the owner. This includes all trophies in any shipment, i.e. a combined shipment with two or more client's trophies within the same shipment. All international trophy shipments will require a 50% deposit and instructions within 30 days of arrival at Wildlife Reflections Taxidermy Studio, INC. Prearranged payment agreement before the international hunt takes place is encouraged. International shipments without a paid deposit or payment agreement will have a daily storage fee of \$35.00. After 60 days without the required deposit and late fees, the owner of any said trophy or trophies will relinquish all rights to the said trophy or trophies; Gifting their trophy or trophies to Wildlife Reflections Taxidermy Studio, INC.*

*A service fee of \$250.00 per trophy will be applied for any "No Taxidermy Work Requested". All shipping costs, including recreating will be added to this fee and paid in full. Before releasing any trophy to anyone.*

*Completed taxidermy work shall be paid for in full within 30 days of notification. Interest of 18% APR will be applied to the unpaid balance after a 30 day grace period. After 30 days of the dated notification a daily storage fee \$5.00 will also be applied.*

*Absolutely NO work will be released from Wildlife Reflections Taxidermy Studio, Inc until the balance is paid in full – NO EXCEPTIONS!!! Checks returned for any reason will result in a \$50 returned check fee.*

*No cancellation(s) after commencement of any taxidermy work is permitted.*

*Shop labor rate per hour is billed at \$55.00*

*Custom form alterations will add 30-40% to the cost of the taxidermy work being performed.*

*Custom woodwork or cabinet base work is not included in the taxidermy price on life size mammals. Simple habitat work is included in price. Upgrades may be added on a quote basis. Woodwork may be from outside sources.*

*Customer is responsible for complying with all State, Federal, and International Game Laws.*
